

Relay For Life Liskeard Prize Draw

1. By entering this prize draw (the “**Prize Draw**”) entrants agree to be bound by the terms and conditions below (“**Terms and Conditions**”).

Eligibility

2. The Prize Draw is open to UK residents aged 18 or over, except individuals involved in the administration of the Prize Draw and employees of Cancer Research UK.
3. The Promoter reserves the right to request evidence of eligibility, including the identity and age of any entrant.

How to enter

4. On or before Wednesday, 1st March 2023, the Promoter will write a post on the Relay for Life Cornwall – Liskeard Facebook page - www.facebook.com/relayforlifeliskeard (the “**CRUK Facebook Page**”) about the Prize Draw (the “**Prize Draw Post**”).
5. Entry to the Prize Draw opens on Wednesday, 1st March 2023 and closes on Sunday, 28th May 2023 (“**Entry Period**”). Entries received outside the Entry Period will not be entered.
6. Entries to the Prize Draw can be submitted in the following ways:
 1. send an email with your name, phone number and the number of entries you would like to accounts@liskeardrelay.org; or
 2. if applicable, providing your name and contact details (phone number and/or email) on a ticket stub provided to you by a Relay For Life Liskeard Committee member and return this information on the stub of the ticket to the member.
7. Entrants may submit more than one entry up to a maximum of twenty per person but can only win one prize per person.
8. Entries must be made directly by the person entering the Prize Draw. Third party, bulk and/or automated applications shall not be accepted.
9. The Promoter does not accept responsibility for incorrect or incomplete personal details provided by a winner, or for any damage or loss resulting from entry into the Prize Draw. The Promoter shall also not be liable for issues of any kind which may prevent, restrict or delay the sending or receipt of an entry, including (but not limited to) technical faults such as network, computer, hardware or software failures. Late, damaged, illegible or corrupt entries, or those not complying with these Terms and Conditions and/or the Facebook Terms of Service (<https://www.facebook.com/legal/terms>) will not be valid. Proof of posting or transmission is not proof of receipt by the Promoter.

Prizes

13. The prizes are non-transferable, non-refundable and non-negotiable. In the event of circumstances beyond the Promoter's control, the Promoter reserves the right to substitute the prizes for similar prizes of equal or greater value or, at its sole discretion, the cash value of the prize.
14. By participating, entrants agree that the prizes are awarded on an "as is" basis and that the Promoter makes no representations or gives no warranties of any nature in relation to the prizes.

Insofar as permitted by law, the Promoter will not in any circumstances be responsible or liable to compensate the winner or accept any liability for loss, damage, personal injury or death occurring as a result of using and/or taking up (or failing to use and/or take up) the prize except where it is caused by the negligence of the Promoter or its employees.

Winner selection

16. The winners of each Prize Draw will be the first three valid entries selected at random from all entries received during the Entry Period in the presence of an independent observer. The draw will take place on Sunday, 28th May 2023 ("**Draw Date**"). Reserve winners will also be selected in case the original winners cannot be contacted and/or do not provide the necessary information. The Promoter's decision will be final and no correspondence will be entered into.
17. The winners will be notified within seven days of the Draw Date by telephone or in person.
18. If a winner cannot be contacted or fails to respond to communications within five days of notification, the prize will be forfeited and the Promoter reserves the right to award a prize to a reserve winner selected as set out above.
19. The Promoter reserves the right to disqualify a winner if it reasonably believes there has been a breach of these Terms and Conditions or a winner's conduct is contrary to these Terms and Conditions and in these circumstances the Promoter also reserves the right to require the return of any prize awarded (if applicable) and select an alternative winner as set out above.

General

20. The Promoter reserves the right to (i) cancel or suspend the Prize Draw; (ii) cancel or refuse any individual's entry and (iii) amend these Terms and Conditions (and will use reasonable endeavours to notify changes to entrants and potential entrants).
21. This Prize Draw is in no way sponsored, endorsed, administered by or associated with Facebook and the entrant agrees to release Facebook from any liability in relation to the Prize Draw or its administration.
22. Any personal data received from entrants will only be used and/or shared with third parties where necessary for the proper purposes of the Prize Draw and in accordance with the Promoter's Privacy Statement at www.cruk.org/privacy.
